Ponderosa Speedway will present a full program of weekly racing series competition on Friday April 16. In action will be the Good Neighbor Pharmacy Super Late Models in a 25 lap, \$1,000 A-Main, the Clayton Homes UMP Modifieds in a 20 lap, \$600 to win A-Main, the Bob Allen Motor Mall Pro Late Models in 20 lap, \$600 to win A-Main, and the D&D Pallet Recyclers UMP Sportsman in a 15 lap, \$300 to win A-Main. All division will time trial at this event, with preliminary events consisting of a quick six dash and heat events in all divisions.

Activities for the April 16 event at Ponderosa Speedway will see the pit area open at 4:00 p.m., with the grandstand area open at 5:00 p.m. A mandatory drivers meeting takes place at 7:00 p.m., with practice set to begin at 7:15 p.m., followed by time trials at 7:45 p.m., and racing taking the green flag at 8:30 p.m. Ticket prices in the general admission area will be \$12 for adults, \$5 for children ages 6 to 12, and children under age 6 are free. A pit pass will be \$25.
